The amount of ethylene glycol used in 2017 increased by 14.3% compared to 2016 due to an increase in production levels. The amount of toluene used in 2017 decreased by 8.9% compared to 2016 due to a decrease in production levels. The amount of xylene used in 2017 was reduced by 100% compared to 2016 as we formulated this ingredient out of our products. The amount of acetone used in 2017 decreased by 7.9% compared to 2016 also due to formulation changes and decrease in production. The amount of dibutyl phthalate used in 2017 decreased by 38.9% compared to 2016 due to decreased caulking sales and production levels. The amount of zinc used in 2017 increased by 2.7% due to increased production levels. The amount of hydrotreated light distillate used in 2017 was reduced by 1.9% compared to 2016 due to product sales mix and production levels. The amount of solvent naphtha medium aliphatic used in 2017 was reduced by 8.8% compared to 2016 due to product sales mix and production levels.

Reformulation of products are continuously considered wherever possible based on a variety of factors including OTR considerations, applicable regulatory requirements, product quality, product performance, cost, customer requirements, etc.

Home Hardware Stores Limited, Beauti-Tone Paint and Home Products Division prides itself on the quality and effectiveness of its products. Over the past years, Home Hardware Stores Limited, Beauti-Tone Paint and Home Products Division has eliminated/reduced the amount of these substances in some of its products through reformulation. Efforts will continue to be made in the future to eliminate or reduce these substances used in our facility as opportunities arise. Any such items and elimination/reduction, where technically and economically feasible, will be implemented and captured in our future annual updates.
