The amount of toluene used in 2018 increased compared to 2017 due to increased production levels. The amount of acetone used in 2018 increased compared to 2017 due to increased production levels. The amount of dibutyl phthalate used in 2018 increased compared to 2017 due to increased production levels. The amount of zinc used in 2018 decreased compared to 2017 due to decreased production levels. The amount of hydrotreated light distillate and solvent naphtha medium aliphatic used in 2018 both decreased compared to 2017 due to deceased production levels.

Reformulation of products are continuously considered wherever possible based on a variety of factors including OTR considerations, applicable regulatory requirements, product quality, product performance, cost, customer requirements, etc.

Home Hardware Stores Limited, Beauti-Tone Paint and Home Products Division prides itself on the quality and effectiveness of its products. Over the past years, Home Hardware Stores Limited, Beauti-Tone Paint and Home Products Division has eliminated/reduced the amount of these substances in some of its products through reformulation. Any such items and elimination/reduction, where technically and economically feasible, will be implemented and captured in our future annual updates.
