## Chemicals Management in Canada

### **Final Order 2020-87-21-01 Addresses 19 DSL Substances Associated with Pesticidal Uses**

All 19 substances have been registered as active ingredients in pest control products under the PCPA. But because these substances were recognized to have hazardous properties under CMP, SNAC provisions are applied if their non-pesticidal uses were to increase.

### **Ministerial Condition Provides Manufacturers a Break**

Ministerial Condition Allows Manufacturers to import 1,2-propanediol, 1,2-dibenzoate (CAS RN 19224-26-1) for Manufacture/Sale of Paint, Coatings, Adhesives, Caulks and Sealants in Canada. However, some requirements and record-keeping obligations apply.

## CMP Phase 2

### **Amendment to Prohibition of Certain Toxic Substances Regulations Delayed to Fall 2021**

This amendment will propose to add certain flame retardants and perfluorinated compounds to Canada's list of prohibited substances in Canada Gazette, Part I. It has been delayed to Fall 2021 and its final approval delayed to Fall 2022.

## CMP Phase 3

### **DSAR for Aliphatic Amines Group Proposes Nine Substances CEPA-Toxic**

The 13 substances were further sub-divided into 4 short-chain amines and 9 long-chain substances which are proposed as harmful to the environment. All four short-chain substances are not proposed toxic. Nine of the 13 substances are CASE-implicated including 3 long-chain (CAS RNs 124-40-3, 61788-46-3, 61789-79-5). All long-chain substances meet the criteria for environmental concerns. Only one long-chain is proposed toxic to human health: DPDAB. Comments are due by May 5.

### **DSAR Proposes All Four Substances in the Ethers Group Not CEPA-Toxic**

The DSAR proposed to conclude that all four ethers (DEE, DPE, DME, DPGME) do not meet any of the criteria. Two CAS RNs 34590-94-8 and 115-10-6 are CASE-implicated.

## **DSAR Proposes Piperazine (CAS RN 110-85-0)**

### **Not CEPA-toxic at Current Levels**

Though **proposed non-toxic at current levels**, piperazine may be considered in future initiatives if its uses increase or change. Piperazine is CASE-implicated. Comments are due on May 12.

### **DSAR Proposes Nine Benzotriazoles Non-Toxic and Six Benzothiazoles CEPA-Toxic**

Only one of the nine benzotriazoles proposed non-toxic, 1H-Benzotriazole, **appears CASE-implicated**. MBT and five other benzothiazoles in the group are proposed CEPA-toxic for the environment. The RM scope document is unlikely to affect the use of CASE products.

### **DSAR for the Hexamethylenetetramines**

#### **Group Proposes Two Substances Toxic for Human Health**

The DSAR proposes to conclude that Quaternium 15 cis/trans-CTAC (CAS RN 4080-31-3) and cis-CTAC (CASRN 51229-78-8) meet the criteria under paragraph 64(c) for dermal concerns and to add them to Schedule I. The third substance, Methenamine hydrochloride, does not meet the criteria. The RM scope does not focus on CASE uses but this approach will be refined later. **Comments are due on May 5.**

### **DSAR and Risk Management Scope Published for Thiophosphate Alkyl Esters Group**

The DSAR proposes to conclude that TPAE-1 meets the criteria under paragraph 64(a) (toxic for the environment). TPAE-2 does not meet toxicity criteria, but follow-up measures are being considered if its use increases. The risk management scope is focused on the **metalworking sector**.

## **CMP Post-2020**

---

### **SciAD Published on *Bioactivity Exposure Ratio: Application in Priority Setting and Risk Assessment***

The **Science Approach Document** (SciAD) provides information on how to use in vitro toxicity data (i.e., data from human cell lines, animal cells, and cell-free biochemical tests) in order to estimate the potential for risk that chemicals may pose to human health. Health Canada examines in vitro toxicity data and applies the approach to 46 chemicals previously assessed under the CMP in order to build confidence in applying the approach going forward. Out of the 46, 27 are believed to be CASE-implicated. This approach may be expanded to contribute to the weight of evidence evaluation for future risk assessments.

## **VOCs & Air Quality**

---

### **Consultation on “Renewed Federal Agenda on the Reduction of VOCs from Consumer and Commercial Products 2021-2028”**

The discussion paper confirms Government's intent to **align with CARB limits for architectural coatings**. It also provides details on proposed regulatory development in the coming years for automotive refinish coatings (Alignment with OTC MERR 2011) and commercial and industrial adhesives and sealants (Alignment with OTC Model Rule and/or SCAQMD Rule 1168). CPCA members should share their concerns prior to April 8.

## **Biocides & Treated Articles**

---

### **PMRA Publishes Q&A Document Clarifying FAQs on Treated Articles**

PMRA has republished its Information Note with a series of frequently asked questions and answers regarding the manufacture, distribution, and import of pesticide-treated articles sold and used in Canada. The FAQ clarifies the definition of “**intentionally added**” pesticides/biocides.

## **PMRA Publishes *What Was Heard* Report on Proposed Integrated Approach to Pesticide Evaluation**

PMRA recently published a "*What Was Heard*" report stemming from multiple stakeholder engagement sessions carried out in 2020, which notes broad stakeholder support for the initiatives outlined in the approach.

## **Workplace Health & Safety**

---

### **Comment Period Extended on Proposed Amendment to Adopt GHS Revision 7**

The deadline has been **extended to April 19, 2021 for CIC members**. CPCA members are encouraged to review CIC industry comments and raise any additional concerns. Depending on how quickly OSHA is going to approve Rev 7, its adoption in CGII could occur as early as 2022.

### **CPCA Joins Industry Associations in Opposition to Health Canada Survey on Consumer Product Exclusion Removal from HPA**

CPCA and other industry groups met to discuss **Health Canada's launch of a public survey** to solve the issue of consumer product exclusion removal from the Hazardous Products Act. The survey seeks to gather more data on workers' issues with CCCR-regulated consumer products used in the workplace without access to SDS, proper WHMIS labels and training. CIC industry groups have not been consulted prior to its release and were united in opposition to the leading nature of the survey. Health Canada refused to remove it and the survey is still on. CPCA members are urged to complete it on **whmis.org** by March 31.

## **Post-Consumer Paint Recycling**

---

### **CPCA and Product Care to Comment on Issues of Concern to Producers in Ontario's Proposed HSP Regulation**

CPCA has **identified several issues of concern for the coatings industry** in the upcoming draft Hazardous and Special Products (HSP) regulations for recycling in Ontario. Updated definitions for paint could mean that more substances may be obligated under the new proposal, including industrial paint and coatings. To that end CPCA will be arguing that the word 'architectural' must be put back in the regulation to specify exactly the target of the regulation. The draft regulation also notes that 'empty' paint cans will still be permitted in the Blue Box program at curbside and should not be required for collection under this regulation. The draft accessibility requirements under the regulation could result in the requirement for many new collection sites/events, which would add additional cost for industry while offering little to no environmental benefit if those events are not successful. CPCA will argue that the current collection system that has been in place for the past six years since Product Care took over from Stewardship Ontario has been successful in meeting and in some cases exceeding establish targets. That effort has seen the addition of 200 more Return-to-Retail sites when none were required under the current regulation. Therefore, some consideration must be given to the success of the program as it's currently run and acknowledge the fact that more sites/events based on a formula without considering the actual outcomes is inappropriate, especially for a consumable product like paint. Comments are being accepted until March 28, 2021. CPCA and Product Care will make an official submission prior to this deadline. The proposed HSP regulation will come into force on July 1, 2021, with an 18-month transition period to the new regulation.

### **Quebec Government Commission to Study Extended Producer Responsibility in New Recycling Plan**

Quebec is moving to **update its provincial recycling program** with a greater focus on extended producer responsibility. A Commission of Inquiry into long-term management of waste is launched to provide a plan to increase recycling volumes and to include a wider variety of commercial products. The outcome will be to have 100 percent of costs covered by producers, similar to Ontario for Electronics, Tires, and MHSW and for Blue Box once the program plan is approved.

## Alberta Launches Formal Consultations to Design a Made-in-Alberta Solution to Plastic, Packaging, and Hazardous Household Waste

The government is seeking ways to better **manage this waste through a circular economy approach**—an extended producer responsibility program that will reduce volume in landfills. The cost and management of recycling shifts from municipalities and municipal taxpayers to those directly producing and consuming goods.

## International Initiatives

---

### ACA Reviews the New EU Chemical Strategy

Last fall, the EU Commission report “**Chemicals Strategy for Sustainability Towards a Toxic-Free Environment**” placed emphasis on responding to an identified hazard, rather than the risk of exposure, embracing the ‘Precautionary Principle. The commission intends to implement a hazard-based approach at the global scale, by introducing new hazard classes into the U.N. Globally Harmonized System of Classification and Labeling of Chemicals (GHS) and seeking to phase-out chemical groups through international conventions and agreements within the next two years. New CLP hazard classes and expanded SVHC criteria are expected by the end of 2021.

### OECD Publishes Guidance for the Identification and Selection of Safer Chemical Alternatives

The Organisation for Economic Co-operation and Development just published a **guidance report** intended to advance broader agreement on a general approach and criteria for the selection of **safer alternatives**, with a focus on chemical substitution. It is intended to advance a consistent understanding of the minimum requirements needed to determine whether a chemical alternative is safer.

PolyFR, a copolymer of polystyrene and brominated polybutadiene, has been used as a replacement for hexabromocyclododecane (HBCD) at high volume. According to teams from the US and UofT, **there is an urgent need for environmental fate and toxicity data** on the modern insulation flame retardant PolyFR. Chemical regulations do not typically call for the same level of scrutiny for polymers as for other substances and the EU is currently discussing proposals to include their registration under REACH.

Update on 2020 Greenhouse Gas (GHG) Reporting Period

**The Greenhouse Gas Reporting Program** is expecting the Single Window system to be open for 2020 GHG reporting on April 15. Emitters of 10 kilotonnes or more of GHGs in 2020 and/or those involved in carbon capture, transport, injection or storage activities in certain NAICS codes are subject to reporting. **The deadline to report is June 1.**

## PFAS Drinking Water Rules: One Step Closer to Final Rule

PFAS drinking water regulations are expected by **the end of 2021**. Many companies falsely assume that any regulation under the Safe Drinking Water Act will not impact them, aside from water utilities. **There are three specific ways** that drinking water limits for PFAS will trigger scrutiny on environmental practices of businesses: (1) effluent discharges into water sources; (2) waste sent to landfills leaching into drinking water sources; and (3) properties abutting or in the vicinity of water sources. Non-compliance could lead to significant fines, cleanup costs, and business interruption.


## New China REACH Enforced

The new **China REACH**, known as China New Chemical Substance Notification (MEE Order No. 12), has been enforced since January 1. New chemicals, which are defined as not listed in the IECSC (Inventory of Existing Chemical Substances), will have to comply with the new China REACH. Those IECSC-listed substances where the use is outside the permitted scope also need to comply.

## Latin American and Caribbean Environment Ministers Agreed on the Region's Chemicals Management Priorities for 2021–2024

**Six priorities and actions** to be taken by the 33 countries in the region:

- Strengthening governance and coordination by boosting capacity and improving science-policy linkages;
- Improving the availability of data on chemicals for environmental risk assessments;
- Priority under SAICM to promote sustainable chemistry and GHS implementation
- Implementing the UN's Basel, Rotterdam and Stockholm Conventions;
